

## General License Agreement for the usage of De Gruyter databases, eBooks and eJournals

### **4. Rights of use, Access rights**

4.1 The contracting parties agree that the databases, eJournal contents and eBooks are copyright-protected in De Gruyter's favour. This applies both to the platform/database and the works in the database and to the copyright-protected works contained therein and to any other protectable elements. For this, use and access are only allowed to the extent expressly permitted by this General License Agreement.

4.2 Access rights only apply to IP addresses registered with De Gruyter. Furthermore access rights can be obtained for additional authentication processes (e.g. Shibboleth) agreed upon by De Gruyter with the Licensee. Access rights apply to the Authorized Sites (Appendix 1ff.) of the Licensee within a LAN (Local Access Network). Access for multiple sites (Multi Site Access) has to be agreed upon with De Gruyter and stated in the respective Appendix.

4.3 Walk-in library users (walk-in-user) are granted access to the licensed databases, eJournal contents and eBooks via computer work-stations within the Licensee's physical premises. All other Authorized Users are allowed to use the licensed databases, eJournal contents and eBooks via computer work-stations within the Licensee's physical premises or - if the Licensee allows this provision - through remote access via the Licensee's secure network. Beyond this, the Licensee is not permitted to reproduce the licensed databases, eJournal contents and eBooks or to make it available to the public.

4.4 Authorized Users are allowed access to the licensed databases, eJournal contents and eBooks for their private use or for purposes of research, to view it and search it and to make individual print-outs or electronic copies of individual articles or chapters which do not constitute more than a small proportion of a database, eJournal or a eBook.

4.5 The Licensee may generate temporary local copies of the licensed databases, eJournal contents and eBooks which are produced for a limited time as an integral and substantive part of a technological process (caching), the sole purpose of which is to allow Authorized Users use in accordance with the contractual conditions and which do not possess any independent economic value.

4.6 The Licensee and the Authorized Users may use appropriate parts of the licensed databases, eJournal contents and eBooks to produce printed teaching materials for use by the Authorized Users within the Licensee's

Authorized Sites; these materials are not permitted to be used for re-sale or any other commercial purpose.

4.7 The Licensee and the Authorized Users are not permitted to use or exploit the licensed databases, eJournal contents and eBooks in whole or in part by sale to third parties, rent, lease, loan or any other means for commercial or trade purposes.

4.8 The Licensee is not permitted to be a commercial party to paid documentation services and to make the licensed databases, eJournal contents and eBooks available in whole or in part for this purpose. In exception to this, however, the Licensee is allowed to respond to a request by another library to generate a print-out of part of the licensed databases, eJournal contents and eBooks (e.g. an eJournal article or an eBook chapter) and to despatch this via non-commercial inter-library loan services. This only applies to paper print-outs; electronic copies may not be made. The use of the "Ariel Interlibrary Loan Software" for the transmission of a small proportion of the licensed databases, eJournal contents and eBooks to a printer/fax of another library is allowed, a transmission to e-mail addresses is not permitted. The transmission of whole eBooks via non-commercial inter-library loan services is not allowed.

4.9 The Licensee and the Authorized Users are not allowed to make parts of the licensed databases, eJournal contents and eBooks available in other networks outside the Licensee's secure network, for example in the internet or the World Wide Web.

4.10 The Licensee and the Authorized Users are not permitted to deploy robots, spiders, crawlers or other automated download programs or other aids to search, index or download the licensed databases, eJournal contents and eBooks continuously and automatically (e.g. systematic download, deployment of retrieval software).

4.11 The Licensee and the Authorized Users may not process, operate on or in any other way alter the licensed databases, eJournal contents and eBooks unless this is necessary for the content to be used in accordance with this General License Agreement.

4.12 The contents are only made available via the respective platform from De Gruyter. For purchased eBooks on De Gruyter's online platform [www.reference-global.com](http://www.reference-global.com) the Licensee (additionally to access via internet according to art. 2.3 and 2.4) has archive rights for its own platform for the use of the Authorized Users. PDFs of the licensed eBooks will be provided to the Licensee on request. Any contents thus made available on the Licensee's platform are subject to these present conditions for access via the online platform from De Gruyter.

4.13 Within the scope of De Gruyter's current corporate principles, the Licensee is also granted access to the contents of previous volumes of an eJournal or what is known as a Yearbook published before the volume currently subscribed and which have never been actively ordered or received. This only applies if these previous volumes are available on the platform Reference Global and only back as far as 1998 as the earliest year of publication. This access is provided on an ex gratia basis. If the current volume is no longer being subscribed to, the access to the contents described in sentence 1 is also terminated. The Licensee's rights of use laid down by legal provisions remain unaffected by the foregoing restrictions (art. 4)

4.14 De Gruyter reserves the right to withdraw individual products or parts of the licensed databases, eJournal contents and eBooks if De Gruyter no longer owns the requisite rights or if there is reasonable cause to suspect that individual products or parts of the licensed databases, eJournal contents and eBooks offend the rights of third parties or are illegal in any other way - for example are defamatory or obscene.

4.15 Authors' names, copyright notices, references to registered marks (esp. brands and company names), logos, other references serving identification or relevant for copyright purposes, together with liability exclusions, legal reservations etc. may not be removed, altered or suppressed.

4.16 The Licensee must in writing or on-line inform in due form the Authorized Users of these licence conditions and oblige the Authorized Users to observe them. Furthermore the Licensee is required to make all appropriate efforts to ensure that

- only Authorized Users are granted access to the licensed databases, eJournal contents and eBooks;

- the Authorized Users are appropriately informed of the importance of observing the copyright and other rights attached to the licensed databases, eJournal contents and eBooks;

- the Conditions of this Licence are adhered to.

#### **Purchase terms**

**Property rights to the product** The licensee acquires property rights to the product with the payment of the purchase price.

**Authorized sites of the Licensee** Staatsbibliothek zu Berlin- Preußischer Kulturbesitz Berlin

**Authorized Users at the Author-ized Sites** Access via in-house network of licensee incl. wide area net-works of all higher education institutions financed either by public or private funding, national, regional and state libraries, academic specialist libraries mainly financed by public funding, research institutions mainly financed by public funding, gov-ernmental institutions, including any of the above mentioned types of German institutions abroad (staff only). Authorized users:

1. Higher Education Institutions: Students including guest students, Faculty including visiting lecturers, Staff and contractors, Walk-In-Users. Remote Access included.
2. Academic Libraries, Research Institutions and Gov-ernmental Institutions: Staff, contractors and Walk-In-Users. Remote Access for registered users.

Further licensee can make the product accessible to inde-pendent academic users residing in Germany without restric-tions. This non-institutional access of individuals shall be per-mitted via individual usernames and passwords subject to a requirement of permanent residence in Germany.

**Access** Access can be granted via the licensor's server, local hosting of the licensee or third party servers.

If access is possible exclusively via the licensor's server, tech-nical access fees must be specified and included in the offer for the duration of access to the licensor's server.

**Usage** Only for academic and personal use, within the usual services of the library.

No further distribution or commercial usage of the contents are permitted.

Copies for personal or academic use are permitted. The incorporation of parts of the Licensed Material in printed and electronic course packs, study packs, resource lists and any other material (including but not limited to multi-media works) and/or in virtual and managed environments (including but not limited to virtual learning environments, managed learning environments, virtual research environments and library environments) is permitted.

**Authentication** Institutional users: Via IP-ranges, Username / Password, Shibboleth and comparable future developments to be agreed by the parties.

Non-institutional users: Via individual registration by Username / Password, Shibboleth and comparable future developments to be agreed by the parties.

**Term / Termination** The licence is for usage of the licensed material through the server of licensor and / or licensee and the relevant special collection field library and / or the server of a contractor of each of those institutions without restriction of concurrent use.

The Licensed Materials or parts thereof may be compiled, indexed and catalogued (including, without limitation, the Header Data and Abstracts) by Eligible Institutions. Anything thereby created or compiled may be integrated into the Products and Services of Eligible Institutions.

The license is for perpetual use of the product. Licensee is authorized to make necessary technical arrangements for long term preservation of the product.

If the product is accessible exclusively via the licensor's technical equipment, licensor warrants the long term unrestricted and non alleviated access. In the case that licensor cannot warrant this access, licensor is committed to deliver the database to the licensee.

Requested standards:

- delivery complete and congruent with the licensed product
- standardised data formats
- standardised character sets (UTF 8)
- metadata and content connected by non-proprietary persistent identifier (e.g. DOI)
- content and applications disconnected
- content deliverable as logical units
- no digital rights management by licensor re-formatting / content migration for the purpose of long-term accessibility and preservation is permitted

**Metadata** The license includes the metadata necessary for an appropriate usage of the product.

The metadata shall be licensed and delivered at no extra costs for non-commercial use by local catalogues, union catalogues and any other library and information system (including but not limited to search machines).

Requested standards:

- delivery complete and congruent with the licensed product
- standardised data formats
- standardised character sets (UTF 8)

Recovery of costs is not being deemed commercial use.

**Usage Statistics** Usage statistics shall be provided compliant to the COUNTER Code of Practice on a monthly basis, containing the usage of each title by each member, private users counted separately. Reports shall contain the purchased backfile years only and no usage of current content data shall be included. The reports shall be delivered no later than three weeks after the end of the previous quarter.

**General** - The publisher agrees to all terms of the "Classics" National Licence.

- Libraries having already purchased the database will be reimbursed with the purchase price paid.
