# Confidential Print: Middle East, 1839-1969

#### 1. Grant of Licence for Licensed Materials and Licence Fee

- 1.1 The material that is the subject of this Agreement is electronic information published or otherwise made available by the Licensor and is described as **Confidential Print: Middle East, 1839-1969** (hereinafter referred to as the "Licensed Materials" (where such term shall include any part of the Licensed Materials, and any data or information extracted from the Licensed Materials).
- 1.2 The Licensee acknowledges that the Intellectual Property (which for the purposes of this Agreement shall mean copyright, trade marks, design rights, registered designs, database rights, domain names or any other intellectual property rights) subsisting in or relating to the Licensed Materials remains with the Licensor and/or its suppliers. The Licensee shall not have any right, title or interest in the Licensed Materials except as expressly set forth in this Agreement.
- 1.3 In consideration of the payment by the Licensee to the Licensor of the licence fee set out on the Licensor's quote (the "Licence Fee"), the Licensor hereby grants to the Licensee a non-transferable non-exclusive perpetual licence to use the Licensed Materials (including the right for the Authorised Users to use the Licensed Materials in accordance with the terms of this Agreement) for the purposes set out in and in accordance with this Agreement. The Licensee Fee is set out in Appendix A.
- 1.4 Save for the rights granted by the Licensee to the Authorised Users, the Licensee shall not grant sub-licences, in whole or in part, of any of the rights granted under this Agreement, or sub-contract any aspects of exploitation of the rights licensed to it, without the Licensor's prior written consent.

#### 2. Authorised Use of Licensed Materials

- 2.1 The Licensee may permit Authorised Users to use the Licensed Materials on the terms set out herein and on condition that such Authorised Users do not grant any further sub-licence.
- 2.2 For the purposes of this Agreement 'Authorised Users' include:
- (1) Individuals who are authorised by the Licensees or the Participating Institutions to access an Institution's information services whether on-site or off-site via Secure Authentication and non-institutional users authorized by the Licensee for access to the Licensed Material via Secure Authentication. These users have access privileges at the following institutions and types of institutions:
- Bayerische Staatsbibliothek
- Universitäts- und Landesbibliothek Sachsen-Anhalt
- Higher Education Institutions financed either by public or private funding
- National, regional and state libraries
- Academic specialist libraries mainly financed by public funding
- Research institutions mainly financed by public funding
- Governmental institutions
- Diocesan libraries and regional church libraries in Germany
- Including any of the above-mentioned types of German institutions abroad
- Participating Institutions

A list of Participating Institutions - which can be widened if required - will be provided to the Licensor by the Licensee before activation of access to the licensed materials. Licensee will provide details as follows:

- Licensing institution name and address
- Licensing institution contact email address
- Licensing institution IP Ranges
- (2) Individuals who are authorised by the Licensees or the Participating Institution to access the Institution's information services whether on-site or off-site via Secure Authentication and who are affiliated to the Institution as a current student (including but not limited to undergraduates, postgraduates and guest students), member of staff (whether on a permanent or temporary basis including retired members of staff and any teacher who teaches Authorised Users) or contractor or registered user of the Institution. Persons who are not currently a student, member of staff, contractor or registered user of the Institution, but who are permitted to access the Institution's information services from computer terminals or otherwise within the physical premises of the Institution ("Walk-In Users") are also deemed to be Authorised Users, only for the time they are within the physical premises of the Institution.

## (3) Non institutional Access

Individuals who are authorized by the Licensee for access to the Licensed Material via Secure Authentification are deemed to be Authorised Users. Non institutional access of individuals shall be permitted via individual authentication subject to a requirement of residence in Germany.

- 2.3 The Licensee may only use the Licensed Materials for the purposes of research, education, teaching or other non-commercial use and subject to the foregoing the Licensee may:
- (1) download unlimited portions of the Licensed Materials;
- (2) store in electronic format in secure electronic data files or print a reasonable portion of the Licensed Materials for use only in connection with specific courses of instruction offered by the Licensee;
- (3) engage in text mining/data mining activities in relation to the Licensed Materials, subject to obtaining the Licensor's prior written consent as set out in section 3.2 if such activities involve automated extraction of data directly from the Licensed Materials;
- (4) store in electronic format in secure electronic data files all or any portion of the Licensed Materials for the sole purpose of data mining; and
- (5) permit its Authorised Users to transmit to a third-party colleague in hard copy or electronically, minimal, insubstantial amounts (defined as no more than 5% [five percent] of the total collection of the Licensed Materials) of the Licensed Materials for personal use or scholarly, educational or scientific research;

Save for video content which is excluded for the purposes of downloading, storing, printing and transmitting.

- 2.4 The Licensee may supply to a user of another library (whether by post, fax or electronic transmission) a single copy of an electronic original of an individual document including any supplementary content published in connection to the document, a practice commonly called Interlibrary Loan.
- 2.5 The Licensee shall comply with all applicable laws in performing its obligations and exercising its rights under this Agreement and in particular the Licensee shall not infringe any moral rights (as defined in German Act on Copyright and Related Rights "Urheberrechtsgesetz", "UrhG") that subsist in respect of the Licensed Materials.
- 2.6 For the avoidance of doubt, nothing in this Agreement is intended to limit in any way whatsoever the Licensee's rights under the fair dealing provisions set out in the Copyright Designs and Patents Act 1988 (as may be re-enacted or modified) or if such acts take place outside the UK, in accordance with any equivalent legislation applicable in that territory (for example under the US Copyright Act of 1976, 17 U.S.C. § 107 and uses free from copyright or rights arising from limitations or exceptions that are provided for in connection with

the copyright protection under German copyright law).

### 3. Restrictions on Use of Licensed Materials

- 3.1 Save as set out in this Agreement, the Licensee shall not:
- 3.1.1 permit any third party or individual to use the Licensed Materials and the Licensed Materials shall not be distributed to any unauthorised users, third parties, or used for any purpose which is not permitted pursuant to this Agreement (including without limitation any commercial purpose, sale of the Licensed Materials, bulk reproduction or distribution of the Licensed Materials or commercially sponsored research);
- 3.1.2 modify, change or develop the Licensed Materials in any way or create a derivative work of the Licensed Materials;
- 3.1.3 remove, obscure or modify any copyright, trade mark or other notices included in the Licensed Materials;
- 3.1.4 re-publish any items from the Licensed Materials, unless the Licensee has first obtained copyright permission from the appropriate copyright holder or archive. Permission from the original source archive/copyright holder in the case of re-publication of figures, tables and brief excerpts from the Licensed Materials in an Authorised User's own scientific, scholarly and educational works is always necessary and the Licensee should also obtain correct wording for all citations and credits from the original source archive/copyholder; or
- 3.1.5 remove, bypass, circumvent, neutralise, or modify any of the technological protection measures used for the Licensed Materials.
- 3.2 In order to protect the integrity of server performance for the Licensee's customers, automated extraction of data directly from the Licensed Materials (for example only, by the use of data mining software) is only permitted subject to obtaining the Licensor's prior written consent and if such automatic extraction of data does not affect the performance of the Licensor's servers. In the event that the Licensor's servers are negatively impacted, the Licensor reserves the right to decline and prevent access to the Licensed Materials to stop any disruption to the Licensor's business. The Licensed Material may be used for text and data mining to enhance services, to encourage scholarship, teaching and learning and to conduct research by the Licensee and Authorised Users according to the following principles, as long as the purpose is not to create a product for use by third parties that would substitute the Licensed Material: Raw data may be extracted from the Licensed Material. Text and data mining may be performed on the unchanged Licensed Material or on extracted data (including but not limited to reproducing, storing, adapting, assembling large collections or extracting substantial portions of data and analysing them). The raw data is research data and may be stored, published and distributed in any medium or form under any licence in order to ensure reproducibility and sustainability, as long as the Licensed Material cannot be reconstructed in its original, human readable form. The Licensor will cooperate with Licensee and Authorised Users as reasonably necessary in making the Licensed Material available in a manner and form most useful to the Licensee and Authorised Users. Attribution must be made to the Licensor in an appropriate manner and form.
- 3.3 Before the Institutionmakes available any of the Licensed Materials to the Authorised Users, the Institution shall use industry standard practices and systems available to ensure that all Authorised Users are aware of end user terms and conditions of use of the Licensed Materials that:
- (1) require Authorised Users to comply with all applicable laws in using the Licensed Materials;
- (2) state that the Licensed Materials being supplied are only for the Authorised User's personal use;
- (3) prohibit reproduction or distribution of Licensed Materials that violates applicable law;
- (4) contain a reservation for the Licensor of all Intellectual Property and other rights in the Licensed Materials; and
- (5) Set out the limitations on access and use of the Licensed Materials as set forth in this Agreement,

(collectively, the "**Terms of Use**"). The Licensee shall provide a copy of such Terms of Use to the Licensor should this be requested by the Licensor.

#### 4. Access to the Licensed Materials and hosting

- 4.1 Upon the Effective Date and providing the Licensee has returned a signed copy of ....
- 4.2 In relation to data mining projects, on written request and subject to the Licensee complying and continuing to comply with the provisions of this Agreement, the Licensor will make available in XML format the document level metadata and, where available, a full text data set contained within the Licensed Materials (the "Data"...) for data/text mining purposes. To ensure data security the delivery method will be at the sole discretion of the Licensor. The Licensee shall treat the Data as confidential information in accordance with Section 9 of this Agreement, shall only use the Data in accordance with the permitted purposes as set out in this Agreement and shall not permit any third party to use the Data.
- 4.3 The provisions set out in Appendix B are part of this Agreement.

### 8. Suspension of access to Authorised Materials

8.1 In the event of any unauthorised use of the Licensed Materials by an Authorised User or the Licensee, the Licensor may suspend or terminate the relevant Licensee's access to the Licensed Materials until the circumstances of unauthorised use are resolved to the Licensor's satisfaction, and/or terminate this Agreement in relation to the breaching Licensee if, after serving a written notice on the Licensee identifying the nature of the breach, the Licensee does not remedy the breach within a period of thirty (30) days after the receipt of the written notice. However nothing in this License Agreement shall make the Licensee liable for breach of the terms of this License Agreement by any Authorized User provided that the Licensee did not cause, knowingly assist or condone the continuation of such breach after becoming aware of an actual breach having occurred. In case of breach by a single Licensee Licensor may only terminate the Agreement or suspend access vis-à-vis the respective Licensee committing the breach. For the other Licensee the agreement remains intact and access is unaffected.>

### 13. Permanent Archival Access

- 13.1 The Licensor uses the services of Portico (www.portico.org/digital-preservation) to enable permanent archival access to be provided in respect of all of the Licensed Materials for the benefit of the Licensee.
- 13.2 Permanent archival access to the Licensed Materials will only be activated automatically by Portico within a reasonable time of any of the following trigger events occurring:
- (1) Licensor No Longer in Business. Licensor is no longer in business or is no longer in the business of publishing or providing access to previously published Licensed Materials.
- (2) **Title No Longer Offered.** Licensor has stopped publishing and is no longer providing access to the Licensed Materials for a period longer than ninety (90) days.
- (3) Back List Titles No Longer Available. Licensor has stopped offering or providing access to some or all of the back list titles of the Licensed Materials for a period longer than ninety (90) days.
- (4) Catastrophic Failure. Licensor has stopped publishing or providing access to the Licensed Materials for a period longer than ninety (90) days due to technical difficulties or any business interruption, bankruptcy, insolvency, receivership or business failure.
